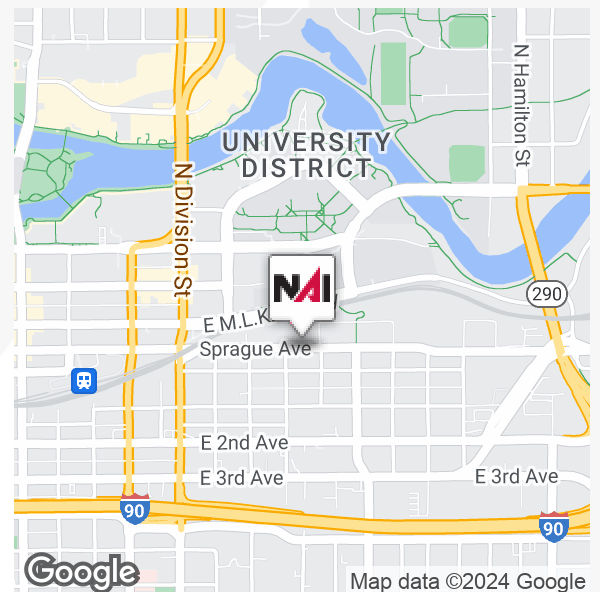

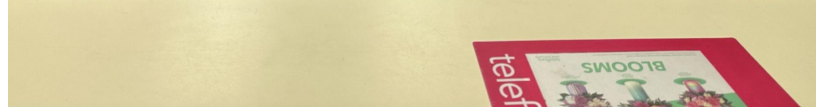

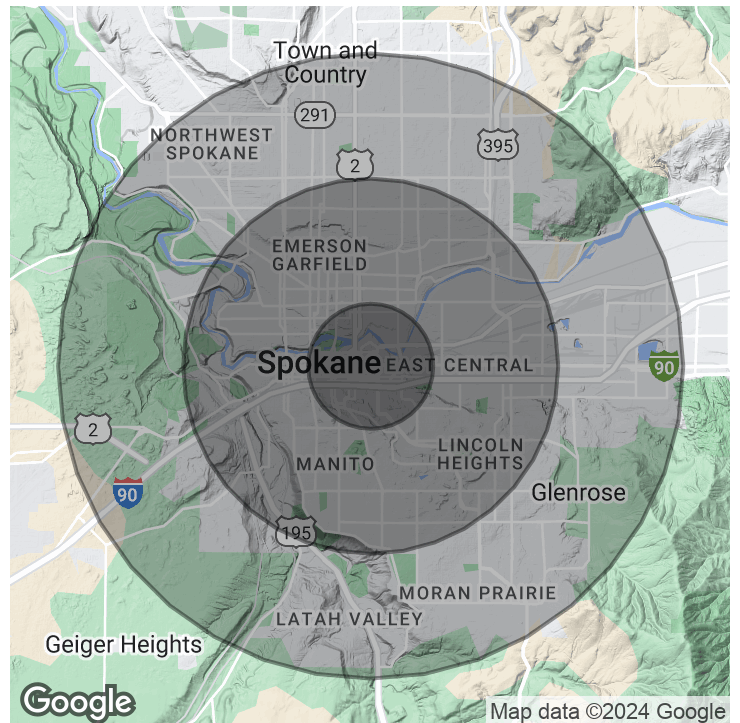

Peters and Sons Flowers, was a collaborative enterprise predicated on a railroading back ground, of the Great Northern Railway magnate Jim Hill, Hills-Yard now Hillyard and a friendship with W.J. Peters. The coal fired greenhouse was built and opened in 1905 in Hill's-Yard, the beginning of the flower business in Spokane. Theodore Roosevelt was President. The Peters family owned and operated the family business for four generations, achieving milestone industry leadership positions.
